

Ass. Sourire de bon coeur

Terms and Conditions (T&C)

1. Application domain

The Ass. Sourire de bon coeur terms and conditions are valid for any items on sale by the Ass. Sourire de bon coeur on its www.souriredeboncoeur.com website.

2. Terms and conditions may be changed at any time by the Ass. Sourire de bon coeur. The version which was in use at the time of a purchase or of an order is valid for the buyer at the date of the purchase/order.

3. Purchase of ware

By internet: **www.souriredeboncoeur.com**

Buyers can get the milling cutters exclusively by internet. The buyer fills out the order form (edited on our website) with exactitude and according to the truth, regarding the required informations. By ware sending, the buyer accept the validity of the terms and conditions, edited on our website, at the moment of his order.

4. When ordering items, the buyer receives a confirmation email within 2 working days. Orders will be accepted by the Ass. Sourire de bon coeur only with this transaction. Informations contained in the confirmation email form integral part of the purchase contract.

Delivery by Post

Items will be sent by the Swiss Post to the buyer's address. The Ass. Sourire de bon coeur decline any responsibility in case of delivery delay.

5. Delivery date

The time allowed to deliver the ordered ware will be of 5 to 6 weeks as of reception, except if another delivery date was concluded. The buyer will be informed if the items are temporarily not available. The buyer accept delivery delays up to 2 months and is not authorized to refuse ordered ware or cancel order, ask for indemnity or money back. The buyer's claims will be settled only with the consent of The Ass. Sourire de bon cœur.

6. Guarantee

The guarantee is effective since ware delivery, excepted other special terms agreed in writing. Claims are accepted only if deposited before 8 days after delivery. After sale discovered defaults must be announced as soon as possible. It does not cover loss, theft, damages of fire, accident, touching up, alteration or inappropriate treatment. Defaults are repaired free by The Ass. Sourire de bon cœur as per the guarantee. Replacement by new parts remains under reserve. Other claims are excluded.

7. Price

VAT is included in the posted prices and shipping costs are EUR 50.00 per 1000 items. Ordered ware must be paid within 30 days after invoice date. If several persons sign an order as buyer, they are jointly responsible. The order will be executed at the receipt of the payment.

8. Place of jurisdiction and duty applied

Swiss law is exclusively applicable. The court is in Fribourg/Freiburg or in the residence of the consumer (for sales in Switzerland).

9. Validity

The present terms and conditions are valid as of March 1st 2008 and may be stricken out by the publication of new dispositions. In case of disagreement about the interpretation of the present T&C, only the German text is valid (<http://www.souriredeboncoeur.com/form/AGBSbc.pdf>).
